नेपाली समाजमा यौन अपराधको कारणहरू

सामाजिक र सांस्कृतिक कारणहरू

नेपालको परम्परागत र सांस्कृतिक मान्यताहरूले यौन अपराधलाई जटिल बनाएको छ । केही मुख्य कारणहरू यस प्रकार छन्:

नेपाल सरकार र कानूनी निकायहरूले यौन अपराधहरूलाई दण्डनीय अपराधको रूपमा परिभाषित गरेका छन् । यस अन्तर्गत विभिन्न कानूनहरूले अपराधीलाई कठोर सजायको व्यवस्था प्रदान गरेका छन् ।

गर्छन् । ३. मुद्दा दायर: अदालतमा मुद्दा दायर हुन्छ । ४. न्यायालयीन प्रक्रिया: अदालतले सुनुवाइ गरी निर्णय गर्छ । ५. सजाय: दोषी पाएमा कानुनी सजाय तोकिन्छ । नेपालको कानुनी प्रणालीले यौन अपराधीहरूलाई कठोर सजाय दिने प्रावधान गरेको भएता पनि, सामाजिक दबाव र कानुनी प्रक्रिया लामो र जटिल हुन सक्छ ।

सामाजिक प्रभाव र परिदृश्य
